### **Information Practices**

Deister Machine Company, Inc. ("Deister") understands that security and privacy are important issues for visitors to the deistermachine.com and sharepoint.deistermachine.com websites (together, the "Site") and recognizes its obligations to keep your information secure and confidential. We maintain the standards set forth in this Privacy Policy to help protect information that personally identifies you. # **Collection of Information**

## **Use of Information**

### **Cookies**

When you visit the Site, Deister or a third party advertiser may store or recognize some information on your computer in the form of a "cookie" or similar file that can help us in many ways. A cookie is a bit of information that is stored on your hard drive that allows the Site to track how you navigate through the Site and areas in which you show interest. Cookies track trends and behaviors but do not extract Personal Information. We may use both session and persistent cookies. Session cookies are used to maintain tracking of a user through an application and expire at the end of a web page visit. Persistent cookies do not expire at the end of the session. Persistent cookies are stored on your hard drive and read by your browser each time you visit the Site. Such cookies contain only a numeric session identifier. We use such information in the aggregate to understand which services and resources our visitors prefer and how those services and resources are used. We may share aggregate demographic/statistical information with third parties.

With most Internet browsers or other software, you can erase cookies from your computer hard drive, block all cookies or receive a warning before a cookie is stored. Please refer to your Internet browser instructions to learn more about these functions. If you reject cookies, functionality of the Site may be limited, and you may not be able to take advantage of certain of the Site's features.
